2023 Health Guidelines

“A fully vaccinated community”

After a successful return to in-person, overnight programming in Summer 2022 and careful consideration from Camp Holiday Trails’ *Medical Advisory Committee (MAC)*, CHT has made the decision to remain a fully vaccinated community for the best interest of all Camp participants. This means that all staff, campers and volunteers will have received either their 1 primary dose of the Johnson & Johnson shot OR 2 primary doses of the Moderna or Pfizer- BioNTech at least 2 weeks prior to their arrival to Camp.

The following information in this guide will help prepare you and your campers for what to expect prior, during and after Camp. We are excitedly awaiting your arrival at CHT for Summer 2023!

All Campers:

- Are required to provide a copy of their COVID-19 Vaccination card prior to their arrival at Camp.
- Agree to a Rapid COVID-19 nasal swab on-site on Opening Day of session
 - *If your child is unable to complete a nasal swab due to their medical condition, please contact [Caitlin Carroll, Director of Programs](#) to further discuss.*
- At this time CHT will not be requiring campers, staff or volunteers to wear face coverings while at Camp, however we encourage anyone who feels more comfortable or is immunocompromised to wear a mask at their discretion. *If Albemarle County is deemed a high-transmission area, CHT will require face coverings in communal indoor spaces to ensure the well-being of all participants and to comply with county ordinance.*

Opening Day

- We will have **scheduled check-in times** which will be coordinated through the use of Sign Up Genius. This will allow families to personally sign up for designated times that best fit your schedule, along with limiting the number of

individuals entering/exiting Camp at one specific time. Families with multiple children please notify [Caitlin Carroll, Director of Programs](#), to arrange your time slot consecutively. **Please note, there will only be a select number of slots per time frame available and it will be a first come first serve basis for sign up.**

- Upon arrival to Camp, we ask that parent/guardian(s) remain in their vehicles until the Med Team has completed their check-in with your family.
- CHT staff will assist in removing camper's belongings from your car and helping your camper settle into their cabin with their fellow cabinmates.
 - We are asking that all campers try to limit their belongings to 2 large duffel bags.
- Where do I go on Opening Day?
 - Drive to **400 Holiday Trails Lane, Charlottesville, VA, 22903**. Approximately 200 yards from CHT's gates you will be greeted by cheerful CHT staff members who will provide you with a name tag and direct you towards our front gate.
 - Upon arriving at CHT's gates you will be greeted by additional CHT staff who will direct you towards our riding ring where check-in will occur.
 - Once you have entered the riding ring you will be guided into a designated spot where a Med Team member will meet privately with you and your camper to complete the medical check-in process.
 - Finally, once your Camper's COVID test results have come back (hopefully negative) then a CHT staff member will assist with tagging their luggage and helping load both your camper and their luggage onto our hayride for transport up to Camp.
 - If a Camper tests positive for COVID-19 they unfortunately will not be admitted to Camp for the designated session. However, CHT will work with your family to transfer the Camper into another session if available or discuss alternative options.

What If My Camper Tests Positive Or Is Asked To Leave Early Due To

COVID-19?

- If your camper cannot attend Camp as a result of testing positive within 1 week of arrival to camp OR tests positive during check-in, we will credit 50% of your Summer 2023 camper fee towards Summer 2024 or refund the amount to you (*based on family preference*).
- If your camper is asked to leave Camp during session due to a COVID-19 related concern, then we will credit 25% of your Summer 2023 camper fee towards Summer 2024 or refund the amount to you (*based on family preference*).
- If space is available, we will also consider transferring your camper to a later session date if requested or placing them on a waitlist for a later summer session.

Closing Day

- Camper pick-up will occur between 10am to 12pm on Friday of the designated session.
- Upon arrival to Camp, families will be directed to our riding ring (where you checked-in) to pick up your child.
 - All campers and their luggage will be in the riding ring
 - You will speak with at least 1 Med Team and Program Team member who will provide you with any medical updates on your child, and ensure you have all medications, supplies, etc.
